GENERAL ORDER NO. 22

IT IS HEREBY ORDERED that no discovery may be conducted by means of interrogatories except as provided by the general orders of this Court. Each party shall only be required to answer two forms of interrogatories as follows:

1. Standard Sets. The standard set of interrogatories shall be comprised of one appropriate standard set of interrogatories established by general order of this Court, including one of the appropriate supplemental standard sets, if applicable. All standard sets of interrogatories may be served with the answer and shall be answered within 60 days by the party served, without objection; provided, however, lawyer-client, attorney's work product, trade secret and proprietary information objections may be asserted. If any such privilege or objection is asserted, the propounding party may conduct further

1 discovery (i.e., interrogatories or depositions) relating to the
2 propriety of said assertion.

3 2. Individual Sets. Each defendant may propound an
4 individual set of interrogatories which shall contain no more
5 than 10 questions, without subparts. The plaintiff may propound
6 an individual set of interrogatories without limitation as to the
7 number of questions. An individual set of interrogatories may be
8 served at any time after the plaintiff or defendant have answered
9 the appropriate standard set of interrogatories. Plaintiff and
10 defendant shall respond to the individual set of interrogatories
11 within the time period and in the manner prescribed by Code of
12 Civil Procedure Section 2030.

13 IT IS FURTHER ORDERED that no party shall be required
14 to answer a particular interrogatory more than once. If any
15 party has previously answered a particular interrogatory, it
16 shall be sufficient to answer by reference to such prior answer
17 and to provide a copy thereof.
