SUBJECT: **2012 UNIFORM BAIL-OUT CITING GUIDE FOR
SUPERIOR COURT, COUNTY OF LOS ANGELES**

The dates in the attached Uniform Bail-Out Citing Guide should be used whenever bail is posted for an appearance in the Los Angeles Superior Court. The appearance date is determined from the date of release on bail, **not the date of arrest**. The exceptions to this policy are narcotics cases filed under sections 11350(a) and 11550(a) of the Health and Safety Code. These two violations are to be cited for appearance **ten days from the arrest date**, at the request of the Office of the City Attorney, to avoid any taint on the case alleged because of lack of diligence in obtaining urine samples. The guide applies to all other infractions, misdemeanors and felonies.

For your convenience, we have also attached an appearance chart for some of the Los Angeles Superior court locations to help you determine to which Department and at what time to cite the defendants to appear.
