All health care defendants in those cases listed in Exhibit B to General Order No. 12 shall now be dismissed pursuant to the instant Order. As such, any health care defendant in those cases listed in Exhibit B to General Order No. 12, that fall within the definition of “released parties”, shall be dismissed with prejudice.**
